She provided statistics pertaining to the development of national and regional bioeconomy strategies, highlighting key milestones and trends.

5.	Status on EUSBSR Annual Forum. Nordic Council of Ministers	KP informed the group that the Annual Forum is scheduled to occur on October 1, 2024, in Visby. He mentioned that the organizers are currently soliciting suggestions for potential workshops to be included in the event's agenda. The forum is set to build upon themes from the previous year, particularly focusing on cooperation with Ukraine and resilience.
